Corangamite Study Area

Notice of Recommendation

Whereas the Land Conservation Council has made recommendations to the Minister for Conservation under paragraph (a) of subsection (1) of section 5 of the Land Conservation Act in respect of the public land in the Corangamite Study Area

And whereas, pursuant to subsection (3) of section 10 of the said Act, the Minister for Conservation has given not less than fourteen days' notice to the Minister administering the Department of Crown Lands & Survey of his intention to recommend that the Governor in Council give notice to the said Department of certain of these recommendations:

And whereas the said subsection (3) provides that where notice of any recommendations is so given it shall be the duty of the government department or public authority to use all diligence and dispatch to give effect to such recommendations so far as they affect any land vested in or controlled by it:

And whereas these recommendations have been published in the form of a book entitled "Final Recommendations - Corangamite Study Area" dated September 1978 and copies have been distributed to the government departments and public authorities concerned:

Now therefore His Excellency the Governor of the State of Victoria by and with the advice of the Executive Council of the said State, doth by this Order give notice to the Department of Crown Lands & Survey of the following recommendations:

- O5 - O12 (inclusive)
- P1 - P12 (inclusive) (P12 should read "12 ha being the Johanna Falls Recreation Reserve and the adjacent allotment 68D, Parish of Aire")
- Q3 - Q7 (inclusive)
- R2 - R10 (inclusive) (R4 should read "2 ha being the existing gravel reserve between allotments 21 and 21P, Parish of Yaughar")
- S5 - S11 (inclusive) (S11 lies within the proposed bushland reserve 18)
- U1

And the Honourable William Vasey Houghton, Her Majesty's Minister for Conservation for the State of Victoria, shall give the necessary directions herein accordingly.
